- 4. THE EQUIPMENT CONTAINED WITHIN THE RAFT IS ACCORDING TO SAMSA POLICY AND GUIDELINES, SAMSA APPROVED; AND**
- 5. THE EQUIPMENT REMAINS FIT FOR USE WHILST IN SERVICE AND IS SERVICED BY AN APPROVED LIFERAFT SERVICE STATION.**

This certificate remains valid until the date stated hereon, unless canceled or revoked by the Authority, which may withdraw this approval at any time for reasons of non-compliance with the applicable regulations referred to in this Certificate of Approval.

It is the responsibility of the manufacturer to notify the Authority of any modifications or changes to the equipment to ensure the continued validity of this certificate.
